Just a few weeks after opening the new substation in Perrydale, Amity Fire Chief Bruce Hubbard hosted an open house and dedication of the new Amity Fire District main station on Saturday, April 30th. The ceremony included the usual speeches, (including one from your Board President), ribbon cutting, cake, and tours of the new facility located on Hwy 99 just at the south end of town.

This new facility is the realization of a dream Chief Swanson first presented four years ago, that is to build a fire station without tax money from his district. With Federal grants, numerous fund raisers, private donations, etc, this new facility was open to the public, with a celebration that included the entire community. Congratulations to Chief Swanson, the Gates Fire Board of Directors, and the entire community of Gates in making this dream a reality.

These new fire stations are a carryover from my previous life, as the State Fire Marshal for this area. I did the fire and life safely plan review on all three, debated sprinkler systems with one of the building officials, and attended the ground breaking ceremony in Gates last July.

And, all three are fully sprinkled. Again, OFDDA congratulates both the Amity and Gates fire districts. ◆

Wallace Selected as State Fire Marshal

Oregon State Police (OSP) Superintendent Chris Brown has announced the appointment of Mark Wallace as the next State Fire Marshal for the Oregon Office of State Fire Marshal (OSFM). Wallace, a 42-year fire service veteran from McKinney, Texas, was appointed effective July 1st to replace Randy Simpson who retired at the end of 2010 following more than 33 years in the Oregon fire service.

He is a graduate of the Executive Fire Officer Program of the National Fire Academy and is designated a "Chief Fire Officer" by the Commission on Public Safety Excellence. He was selected as a member of the Institution of Fire Engineers, an international association of fire service professionals, and is a designated "Certified Emergency Manager" by the International

Association of Emergency Managers.

"I am honored to be selected as your new State Fire Marshal. This is an exciting opportunity and I look forward to meeting with, listening to and building relationships with Oregon's citizens and our fire service partners," said Wallace.

Brown extended his appreciation to Chief Deputy State Fire Marshal Jim Walker who served as acting state fire marshal following Simpson's retirement until a replacement was named.

Recommendations For All New Board Members

Welcome to all of you new and for that matter, not so new, Directors. One of the non-legal areas of advice we give our district clients involves new Board members.

- · We recommend that new Board members take a facilities tour. This would include all stations.
- Next we recommend there be a 'major issues' review. Many times this can be accomplished by simply providing a new Director with the last 6 to 12 months of Board minutes.
- · A budget review would then be appropriate, especially if the new member was not involved in the budget process. This would include providing a copy of the newly adopted budget, as well as the budget message. If there were any major changes, they could be explained to the new member.
- · I recommend providing a copy of, or at least referencing, ORS Chapter 478. This is the statute that gives authority to rural fire protection districts. As a special district, a fire district generally has the authority to do only those things specifically authorized in ORS Chapter 478.
- · For new Board members it is important to read the Board Members Guide that was published by OFDDA and SDAO.
- · Review your District policies, especially those that impact the authority of a Board member, procedural matters in regard to establishing items for the agenda, and general Board operations.

Having new Board members is also a good opportunity to update, or at least review with the Board, Capital Asset Replacement Schedules. This includes buildings, as well as apparatus.

With the exception of the facilities tour, all orientation issues can be discussed in an open meeting. The new Board member then receives input of the continuing Board members as well. Just a reminder – if the orientation involves three or more Board members at one time in one place, it would be a public meeting and would require notice.

The goal of the above is to get new Board members oriented with both the background on the District as well as information on issues that will come before the Board. If you have not done so in a recent period of time, this may provide a good opportunity to update the District's short- and long-term goals.

Always remember, you are now a member of a team and, except at a meeting, have no special authority. I hope all of you will be able to take advantage of the materials and education provided at the OFDDA/OFCA November conference in Seaside. Also, watch for special presentations provided in different areas around the state over the course of the year. •

Firefighter Cancer Presumption

Over the course of the last year, firefighter presumption laws have been the center of great debate across the state of Oregon. With a growing number of presumption centered claims mounting, what should Oregon Fire Districts do to reduce the risk of their members being denied benefits as a result of these laws?

ORS 656.802(5): Twelve types of cancers

Brain cancer, Colon cancer, Stomach cancer, Testicular cancer, Prostate cancer (but not if it was first diagnosed after the firefighter reached the age of 55); Multiple myeloma; Non-Hodgkin's lymphoma,

The physical examination required to qualify for the presumption under subsection 4 must be of the type that a court would find sufficient to reveal evidence of a disqualifying pre-existing condition.

Reducing the risk associated with presumption starts with learning the law and what presumption covers. Firefighter's presumption is outlined in ORS 656.802 (4) and (5), Occupational Disease.

ORS 656.802(4)

Conditions of the lungs or respiratory tract (e.g., lung cancer, emphysema, chronic bronchitis, etc.);

Hypertension (i.e., high blood pressure); Cardiovascular-renal disease (which may cover heart attacks, strokes, kidney damage, etc.); and

Throat cancer; Mouth cancer; Rectal cancer; Breast cancer; and Leukemia.

Although 12 types of cancers fall under the presumptive status, there is no guarantee that diagnoses of one of these cancers will automatically justify payment of workers compensation benefits. The presumption only applies to certain firefighters. Fire chiefs, fire marshals, and the like may also qualify, provided they have had five years of firefighting experience during their careers. EMTs may not qualify for the presumption, unless they actually perform firefighting work. A firefighter does not qualify for the presumption until he or she has worked for at least five years as a firefighter. Conducting a baseline physical prior to any firefighter performing district duties will greatly reduce the risk of potential benefit denial due to preexisting conditions.

The physical examination required to qualify for the presumption under subsection 4 must be of the type that a court would find sufficient to reveal evidence of a disqualifying pre-existing condition. It must include the customary tests that a physician would use under the circumstances to screen for the presence of a pre-existing condition.

Recommendations to Reduce the Risk

- 1) Conduct baseline physicals for all new members of your fire district
- 2) Set appropriate assumed wage for district volunteers workers compensation
- 3) Have a supplemental Accidental Death and Dismemberment policy in place
